4. Transfer of proven technologies from laboratory to land
5. Promote and co-ordinate research on emerging infectious disease of livestock and poultry
6. Offer expert guidance to the various livestock and poultry farmers, to tackle the disease problem in their farms
7. Creation of a team of specialists with necessary laboratory facilities to undertake on the spot disease investigation of endemic and emerging disease of livestock and poultry.

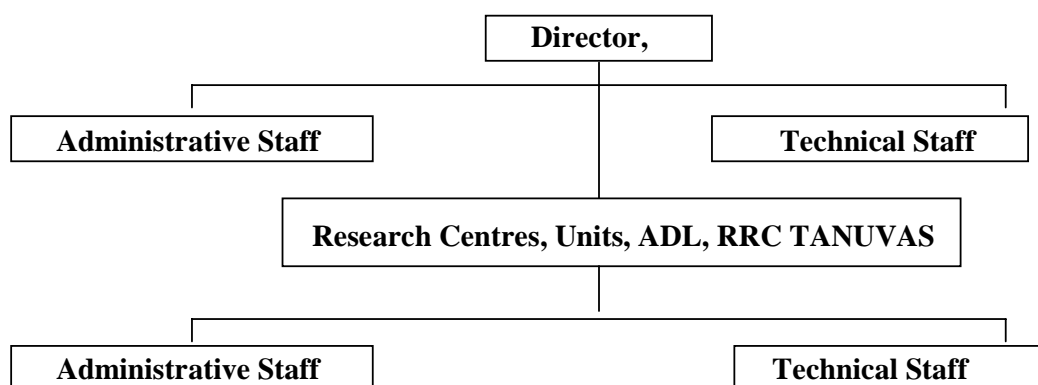
